RLCWA – June 14 – Mark McConnell reported meter replacement project still on going. They present a map at the meetings showing what has been finished versus what is still to be done and if there are any problems.

Stormwater – June 14 – No meeting in June but hearing tomorrow in Elyria at 9:30 am for ditch.

LCTA – June 15 – Forrest Mohrman reported 23 present which is an increase from last meeting. Lorain County Health District was present and discussed failing septic systems

and grant that is available till November 2018. We do have a new Sheriff and since they are short-handed they will try to make the meetings when someone is available. Losing battle on drugs and break-ins are on the increase.
