




TRUSTEES APPOINTED

Lorain County Probate Judge James Walther appointed Mark Diedrick and Andrew Lake on September 16th to replace former trustees that resigned in August.

Mark Diedrick was appointed to replace Walt Bredel whose term was to end December 31, 2027, but since Walt Bredel served less than two years, the seat will be required to go up for reelection in 2025. Mark is a former Pittsfield Township Trustee who decided not to run for reelection in 2023.

Andrew Lake was appointed to finish the remainder of Forrest Mohrman's term, which ends December 31, 2025. This seat will be up for election in 2025. Andrew has lived in the township for 13 years with his wife and children and is a U.S. Army veteran.

SOUTHERN LORAIN COUNTY OFFICE ON AGING

Were you aware that the Lorain County Office on Aging has a satellite office in Wellington? They serve senior residents living in Pittsfield, Huntington, Brighton, Penfield, Wellington and Rochester Townships.

The mission of the Office of Aging is to provide support resources, and advocacy for older adults to age successfully in Lorain County. They provide supportive services for older adults and their families, transportation to medical appointments, restaurant vouchers, Farmer's vouchers, financial assistance, benefits counseling and education, housekeeping and information resource gathering.

The OTA is excited to announce the OTA Scholarship Program will begin accepting applications in September. Each year, **we will be awarding up to five high school seniors \$1,500 each** for their future education. Since 2005, the scholarship has provided support to high school seniors residing in Ohio's townships and show excellence in their communities and schools.

Eligibility:

- Must be a high school senior;
- Have at least a "B" average (cumulative) or equivalent overall GPA;
- Be a U.S. citizen and a resident of a township in Ohio; and
- Must plan to attend a university, training program, or vocational school in Ohio.

OTA Scholarship Options

Academic Achievement (2): For a student who excels academically. To qualify, a student must have a cumulative "B" average.

Local Government Achievement (2):

For a student who demonstrates outstanding citizenship through service and participation in community activities.

Trade School Scholarship (1): For an excellent student who is choosing to attend a vocational or trade school. To qualify, a student must have a cumulative "B" average and complete the scholarship questionnaire.

Application Process

For all scholarship applications:

- Complete the online application
- Submit a state of activities, honors, and leadership accomplishments
- Submit a copy of your most recent transcript
- Two letters of recommendation from teachers and/or community leaders
- Applicants must attend at least one official meeting of township officials and complete the attendance form, which can be found on the scholarship page on the OTA website, with signatures from at least two elected officials

Academic Achievement:

Write a 500 word (max) essay describing the importance of local government.

Local Government:

Write a 500 word (max) essay describing a community project/event that made an impact on your life.

Trade School:

Complete the questionnaire to be submitted with your application.
